In consideration of being permitted to join Granite State Mini Sprints Racing Club, Inc. (Hereinafter called "GSMSRC") and being permitted to participate in or be a spectator at GSMSRC membership events during 2019

I hereby

1. Release, waive, discharge, and promise not to sue GSMSRC, any of its officials, any of its members, any of its sponsors, or car owners, drivers, pit crews, for personal injury or property damage which I sustain during the 2018 - 2019 arising out of a GSMSRC event, whether my loss is caused by the negligence of GSMSRC or its members. This does not waive rights of suit in the event that an action is termed criminal within the jurisdiction of applicable law.
2. I agree to indemnify and hold harmless GSMSRC, its officials and members for any loss, liability, damage, or cost which may incur due to my presence at a GSMSRC event, whether I am competing, officiating, or observing a GSMSRC event.
3. I assume the risks inherent in automobile racing and assume responsibility for the bodily injury or property damage which those risks can cause.
4. I reserve to GSMSRC and its members and officials, any rights to publish, produce, copyright, duplicate, reproduce upon hats, tee-shirts, and other such novelty concession items, written articles about me, photos and drawing of my likeness or of my racecar. This does not prohibit me from producing promotional products, nor does this allow GSMSRC to take any proceeds from material produced by me, unless marketed by GSMSRC.
5. By signing below, I agree to follow all the rules and regulations and responsibilities as printed in the GSMSRC rules. I hereby release the officials of GSMSRC from damages resulting from their decisions and/or interpretations of rules.
6. I have read the forgoing and understand its contents and I agree that if any of the paragraphs or provisions of this contract are deemed illegal, the rest of the document shall stand in full force and effect.
